


Ivanti Unified IT Enterprise License Agreement

You have two choices of ELA: either a **Pick 2** or the whole **Unified IT**, which includes all the primary solutions from five product families.



- **Pick 2:** Choose any two product families and you get all the primary products within those families.

Gain Ivanti Cloud and Greater Visibility

The ELA also provides additional products and functionality not included with each Ivanti product.

- **Ivanti Cloud:** Includes all core cloud services from Ivanti Cloud including real-time capabilities, Smart Advisors, data services, and automation.
- **Xtraction Dashboards:** Choose a Pick 2 ELA and get the enterprise server, additional analysts, and unlimited viewers. Choose the Unified IT ELA and receive 10 additional connectors to popular third-party vendor data.
